The possibility of putting some money into an interest-earning savings account was raised. It was reported that ARGA currently has two accounts, one earning some interest.

Auditing requirements for ARGA were also raised. It was reported that ARGA is incorporated in South Australia and does not have enough assets to be required to be audited.

The current membership of ARGA stands at about 120 members. Members from the Australian Clay Minerals Society who received free membership from the 2014 ARGA conference will drop off the membership list this month.

6. Election of new committee

Ordinary members: Stephanie McLennan, Nadir de Souza Kovacs, Ian Roach.

Carmen Krapf proposed the next conference to be in South Australia, near Port Augusta. Possible dates were discussed and the ongoing difficulty of finding a date that suits academics, students, government, and others.

7. Other business

There was concern raised with the future of ARGA.

Why is ARGA not a specialist group of the Geological Society of Australia (GSA) – this would require ARGA members to also be members of the GSA, which is considerably more expensive than ARGA membership. Being a specialist group also comes with considerable administrative expense. It could also isolate ARGA members who are not geologists and could narrow the reach of the association.

Concerns were raised over the lack of interest in the association and that it could die-out.

There is an UNCOVER symposium at the upcoming Australian Earth Sciences Convention in Adelaide but not regolith session or representation from ARGA.

The possibility was raised of ARGA affiliating with another group, not necessarily the GSA.

It was suggested that a piece on the 2016 ARGA conference is written for the Australian Institute of Geoscientists Newsletter and also the GSA newsletter. Ken McQueen volunteered to write a short article.

MTEC courses will now be run by the University of Adelaide.
